ACCIDENT INVESTIGATIONS:

On March 20, 2021, an accident occurred on a temporary amusement ride known as 35 Foot Ferris Wheel (C-19663), owned and operated by Special Event Attractions. At the time of the accident, the ride was located at 73605 Jack Clark Court in Thousand Palms California. During ride operation, a sweep light fixture became detached from the ride and contacted an adult female patron who was walking near the ride area. As a result, the patron sustained minor head and shoulder injury. The patron self transported to a local hospital where she was evaluated and released. As a result of the accident investigation, the Division issued several requirements to the owner/operator. A subsequent inspection on March 24, 2021 was performed, the requirements were cleared and the ride was released to commence public operation.

ENFORCEMENT ACTIVITIES:

On Saturday, June 26, 2021, The Division responded to information obtained on Friday June 25, 2021 indicating that rides were set up and operating without valid permits to operate. According to the information, the rides were set up to operate for an event located at 11278 Los Alamitos Blvd. in Los Alamitos California. During the inspection, the Division observed a 4 in 1 Bungee Trampoline ride owned and operated by Elite Special Events Attractions and a Mechanical Bull owned and operated by Rides Toros El Matador. At the time of the inspection, permits to operate could not be issued due to requirements pertaining to missing operator training, lack of a pre-opening inspection, missing insurance and failure to submit an application to obtain an operating permits.

On Tuesday November 23, 2021, the Division responded to information obtained that same day indicating that several rides were set up and operating without valid permits to operate. According to the information, the rides were set up to operate for an event at St. Gregory School located on 2215 E. Colorado Blvd. in Pasadena California. During the inspection, the Division observed Children's Swing Ride, Ferris Wheel and Tubs of Fun Ride operating without valid permits Upon investigation the Division discovered the rides were owned and operated by David's Party Rentals. At the time of the inspection permits to operate could not be issued due to damaged equipment, safety related deficiencies and lack of a pre-opening inspection. Orders prohibiting use of these rides were issued to the owner/operator.

On Saturday September 18, 2021, the Division responded to information obtained on September 17, 2021 indicating that several rides would be set up without valid permits to operate at an event in Rio Linda California. According to the information, rides would be set up at 7041 Rio Linda Blvd. in Rio Linda California. During the inspection, the Division observed a 4 in 1 Bungee Trampoline in operation and a Portable Zip Line being set up with intent to operate. The rides were owned and operated by E4 Advisors Inc. DBA SacBounce.com. During the inspection, the Division issued orders prohibiting use of the rides for several safety related deficiencies related to improper installation, missing structural components, lack of a pre-opening inspection and failure to submit an application to obtain operating permits.

INSPECTIONS:

The following table lists owner/operators that operated portable amusement rides in the State of California, the number of rides inspected for each owner/operator, the number of annual and temporary permits issued, and the number of rides reinspected during the 2021 operating season.

After an inspection of a portable amusement ride that is found to comply with all applicable regulations, the Division issues an annual operating permit.

When an inspector observes a violation deemed non-critical to the safe operation of a portable amusement ride but requiring corrective action, the Division issues a temporary operating permit expiring on an assigned date within 30 days after issuance.

When an inspector observes a critical violation, no permit is issued.
