ACCIDENT INVESTIGATIONS:

On April 8, 2022, an accident occurred on a temporary amusement ride known as the Century Wheel (C18252), owned, and operated by Butler Amusements. At the time of the accident, the ride was located at 2600 Geneva Ave. in Daly City, California. During normal ride operation, three teenage patrons jumped from one of the gondolas. Two patrons were uninjured and ran off. One patron stumbled and fell, landing on an air tank below the ride. As a result of the fall, the injured patron sustained a laceration to the head, was treated by Daly City Police and transported to San Mateo Medical Center via ambulance. At the time of the Division's investigation, no safety hazards were observed, and the ride was released to resume public operation.

On October 23, 2022, an accident occurred on a temporary amusement ride known as Sizzler (C17485), owned and operated by Paul Maurer Shows. At the time of the accident, the ride was located at 4702 North Figueroa St. in Los Angeles, California. While attempting to exit the ride, a female patron tripped and fell when her right foot caught a molded fiberglass lip of the inside of the passenger carrier. As a result of the patron's right foot being caught, and the force of falling, the patron suffered a broken leg. Los Angeles Police Department was on scene and rendered aid. The patron was transported to Los Angeles General Hospital via ambulance. As a result of the Division's accident investigation, several requirements were issued to the owner/operator prior to releasing the ride to resume public operation.

INSPECTIONS:

The following table lists the owner and operators of portable amusement rides in the State of California, the number of rides inspected for each owner/operator, and the number of annual and temporary permits issued during the 2022 operating year.

After an inspection of a portable amusement ride that is found to comply with all applicable regulations, the Division issues an annual operating permit.

When a Division inspector observes a violation deemed non-critical to the safe operation of a portable amusement ride but requiring corrective action, the inspector issues a temporary operating permit that expires on an assigned date within 30 days after issuance.

When an inspector identifies a violation deemed critical to the continued safe operation of a ride, no permit is issued.
