This list was established pursuant to Labor Code 6401.7(e)(3)(A). The private sector average “DART” (Days Away, Restricted and Transferred) rate in 2018 was 2.1. Cal/OSHA’s High Hazard Industry threshold is >200% of the private sector average DART, or >4.2.

Exceptions: The following NAICS will not be targeted; DARTs are \leq 200% of Private sector average
